# LeadingAge Joins Lawsuit Against HHS and CMS

LeadingAge has made a **commitment** to use every tool available —legislative, legal, and regulatory—to both address the fundamental issue of building the long-term care workforce and halt implementation of the Centers for Medicare and Medicaid Services' (CMS) final staffing rule. LeadingAge intends to file to join **the American Health Care Association lawsuit** against the Department of Health and Human Services (HHS) and CMS. We are in full agreement with the arguments made in the lawsuit.

Mandates, as we've said repeatedly to Congress, to the Biden Administration, and to HHS, are not the right approach to achieving the shared goal of ensuring older adults' and families' access to quality long-term care. They will without question impact our nonprofit, mission-driven nursing homes' ability to provide care and services.

Eric Boley, LeadingAge Wyoming President, along with other state associations strongly encouraged LeadingAge to join the lawsuit. The national LeadingAge board reconsidered their stance and ultimately decided to join AHCA in their lawsuit.
