As providers prepare for the October 1, 2025 implementation date for the Hospice Outcomes and Patient Evaluation (HOPE) tool, the Centers for Medicare and Medicaid Services released two new resources: a 30-minute online "Train-the-Trainer" program, and the Hospice Quality Reporting Program (HQRP) Quality Measure Specifications User's Manual chapter for HOPE Process Measures.
